3. The group of people who have access to data

ONLY the colleagues of the data administrator and his collaborators can have access to the personal data given by the users and the automatically known data from the technical operations.

Personal data - beside the colleagues of the data administrator and his collaborators - are not given to any third party. This is not referred to the incidental, compulsory data transfer ordained by law.

Data administrator analyzes before completing each and every official data request regarding each and every piece of data if there is the legal basis of data transfer, asks the opinion of the Nemzeti Adatvédelmi és Információszabadság Hatóság (National Confidentiality and Freedom of Information Authority) if necessary.

With the acceptance of the terms of the personal data managing, you also accept that the data administrator can also give your personal data to its successor. If you ask for, the data administrator deletes all personal data before transferring it to its successor.

4. Confidentiality actions

Data administrator does every necessary step for managing and storing the data securely. Processed data are stored and operated in a highly available, reliable, dedicated server system.

We inform you that messages forwarded on the internet, without protocol (email, web, ftp etc.) are very vulnerable, regarding those web threats, which aim to have unfair acts, debate contracts, or reveal and modify pieces of information.

From these kinds of threats, the service provider does every necessary precaution, which can be expected from him. Systems are watched to record every security deviation and it can serve as a piece of evidence in case of every security event. In addition, the system observation makes it possible to check the efficiency of the applied precautions.

5. Possible legal remedies

The person concerned can ask - by the contacts mentioned in Point1 - to inform him/her about the process of personal data managing, correct his/her personal data, and to delete or block his/her personal data – not included the compulsory data.

After the request of the person concerned, data administrator gives information about the data being processed by him, their source, the aim of the data managing, its legal basis, its duration, the name of the data administrator, his/her address, any acts regarding data managing, in addition - in case of transferring the personal data of the person concerned - also gives information about the legal basis of data transfer and to whom it has been transferred. Data administrator informs the person concerned after the reception of the request of the person concerned within 30 days in written form. It is free. Data administrator denies giving information to the person concerned only in cases defined by law.

In case of denial of giving information, data administrator informs the person concerned in written form that based on which point of the law his denial happened. In case of denial of giving the information, data administrator informs the person concerned about his/her possible legal remedy.

If the personal data does not appear to be real and the real personal data are available for the data administrator, personal data are modified by data administrator. Personal data are deleted if:

- a) managing data is illicit;
- b) the person concerned requests it according to this Confidentiality information brief;
- c) the data are incomplete or wrong and this status can not be solved legitimately - if the deletion is not banned by law;
- d) the aim of data managing ceased to exist or the duration of storing the data (defined by law) expired;
- e) deletion was ordained by court or any competent authority.

Instead of deletion data administrator blocks the personal data if the person concerned requires it or based on the information available and it can be supposed that deletion would harm the legitimate interest of the person concerned.

So the blocked personal data can only be managed until that aim of data managing is in existence which excludes the deletion of the personal data.

Data administrator marks the personal data being processed by him if the person concerned disputes its correctness or precision, but the falseness and inaccuracy of the debated personal data can not be stated clearly.

Data administrator about the modification, blocking, marking and deletion informs the person concerned and those people to whom these personal data have been transferred before for data processing purposes. The notification can be ignored if this does not violate the individual's legitimate interest regarding the aim of the data managing.

If data administrator does not fulfill the requirements of the person concerned about the modification, blocking, or deletion within 30 days after the reception of the requirements, he informs the individual concerned about the factual and legal causes of rejection for modification, blocking or deletion. In case of rejection of the requirement for modification, deletion or blocking, Data administrator informs the individual involved about his/her possible legal remedy.

The person concerned can deny the managing of his/her personal data if:

- managing his/her personal data (forwarding/transferring them) is only necessary to fulfill the legal requirements of data administrator or to validate the legal interest of the data administrator, data receiver or any third party, except in case of compulsory data management;

- personal data are used and transferred for direct business, poll or scientific research purposes;
- other cases defined by the law.

The BOGDANY PETROL LTD. analyses - and at the same time suspends - the block, within the shortest possible period of time, but maximum within 15 days, and its result is sent to the requester in written form. If the objection has a purpose, data administrator stops the data managing -included the further data reception and data transfer - data are blocked and also he informs those people about the objection and actions made based on the objection - to whom the personal data had been transferred before and those who are obliged to make an act for the legal affiliation of the objection.

If the person concerned does not accept the decision made by the data administrator, he/she can go to court – within 30 days from the publishing of the denial.
